### **2. CONSIDER MORATORIUM ON ORDINANCE NO. 919 REGARDING SECTION 1 PART A-, SECTION 1 PART B-1, B-2, B-3, PART C-1, C-2, C-3, D-1 THROUGH D-3, PART E AND PART F**

Mayor Bryson explained that at the previous City Council meeting Ordinance No. 919 had been discuss and approved. It was recommended that a special meeting be held to discuss placing a moratorium on sections of the ordinance. Mayor Bryson said the moratorium would cover all but the section regarding the collection of \$5.00 to be submitted to the state.

City Manager Grayson Bottom said \$5.00 is not specified in the ordinance in the event the amount should change it would not affect the ordinance.

Councilman Marcy asked how long the moratorium would last.

City Manager Grayson Bottom said it would not be removed until the State of Oklahoma provides more specific information and definitions regarding general contractors.

Bottom said the second step to this process will be reviewing the \$500.00 level for requiring a building permit. He said inflation has affected that number and should be considered. He said the level for requiring a building permit should be changed to an appropriate level.

Motion was made by Councilman Jordan and seconded by Councilman Marcy to place a moratorium on Ordinance No. 919 regarding Section 1 part A-1, Section 1 Part B-1, B-2, B-3, Part C-1, C-2, C-3, D-1 through D-3, Part E and Part F.

Mayor put the motion to a roll call vote:

Mayor declared the motion carried.
