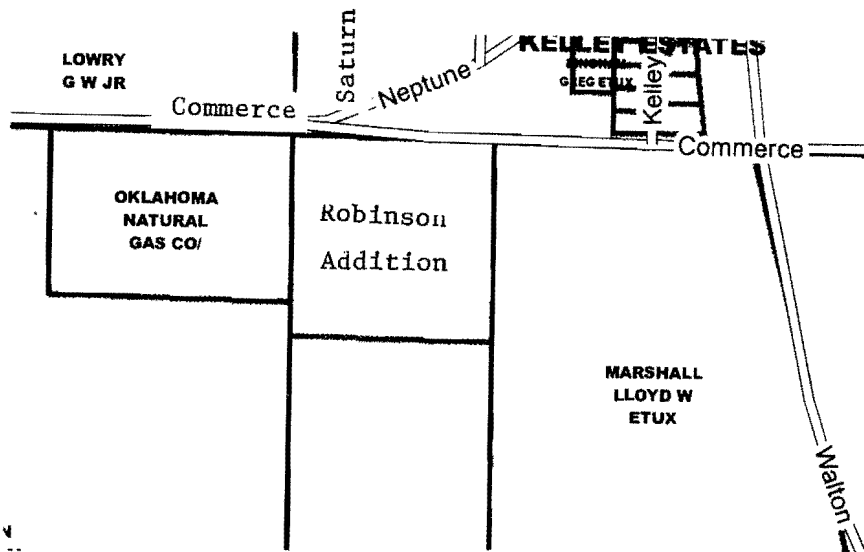


**NOTICE OF ANNEXATION - PUBLIC HEARING**


Requesting that the property be annexed by and to the City of Clinton and made a part of the land area within the corporate boundaries of the City of Clinton.
