**AGENDA ITEM NO. 2: CONSIDER AND TAKE ACTION ON CANUTE WATER AGREEMENT  
EXTENSION**

City Manager Mark Skiles presented the Second Amendment to Water Purchase Contract with the Town of Canute. He said the agreement had been approved by Canute at a meeting yesterday. He said bid are to be received on November 13, 2015 for the Canute Waterline and will be on the Public Works Authority agenda for November 17, 2015.

Trustee Rodolph said a meeting with Canute people, City Attorney Ryan Meacham and Pat Cornell was held yesterday and this agreement is a direct reflection of what was agreed. He said it gives Clinton latitude on paying. He said Clinton would not be paying for water not used.

City Manager Skiles said it should not be longer than January 2016 before written approval from the Department of Environmental Quality is given.

Trustee Rodolph said this is a good agreement for both parties.

Motion was made by Trustee Rodolph and seconded by Trustee Martinez to approve the second amendment to Water Purchase Agreement contract with the Town of Canute.
