- a. Frisco Avenue closed from 7th Street to 4th Street, including intersections beginning at 5:00 P.M. until 8:30 P.M.

- c. Use of Englemen Park from 3:00 P.M. until 8:30 P.M.
- d. Lights to be turned on in Englemen Park at 5:00 P.M.
