Full Description of proposed Fund usage for Meeting/Event:

To organize a platform to further the development of youth softball in the Clinton community and the surrounding areas, to enhance player development and encourage interest and enthusiasm for the sport, and to promote sportsmanship and competition in one complex. This grant would enable us to make entry fees more affordable for each team to allow us to reach more teams that would have to drive further to play here that would otherwise not be able to participate. Costs of fall league include softball supplies, awards, equipment, umpires, and other unforeseen items. Capturing this grant would enable us to bring teams into the Clinton community three/four nights a week for four weeks. Also, bookended by two weekend tournaments, hopefully resulting in the possibility of hotel room bookings on those weekends by some of the farther distance teams. Although we can't guarantee hotel room sale, we would have large numbers of out of town guests spending their money here in Clinton eating, getting gas, etc. for an estimated total of 19 nights. This grant would allow us to facilitate as many teams that wish to participate and hopefully keep bringing them back each year.
