Dear Robert,

I am writing you on behalf of Allied Waste Systems, Inc. (hereinafter "Republic") regarding the Lease Agreement dated November 2, 1993, and subsequent amendments between the Clinton Public Works Authority (the "PWA") and Republic (hereinafter, the "Lease").

Pursuant to Section 3.1, as amended, of that certain Solid Waste Disposal Agreement by and between Republic and The City of Clinton Solid Waste Authority (the "Authority"), dated August 14, 2008 (the "Agreement"), upon termination of the Agreement, the Lease shall also terminate.

Pursuant to Section 4.2 of the Agreement, simultaneously with this letter, Republic has delivered a 180-day notice of termination of the Agreement to the Authority. The effective date of the termination of the Agreement will be July 31, 2023 (the "Termination Date"). Therefore, this notice confirms to the PWA that the Lease will also terminate as of the Termination Date.

While we value our longstanding relationship with the PWA, Republic cannot continue to operate the Authority's facilities under the terms of the current Agreement.

As of the Termination Date, Republic and PWA generally release and discharge each other, and their respective officers, directors, shareholders, partners, agents, representatives, employees and attorneys, both past and present, of and from any and all claims, debts, liabilities, obligations, costs, and causes of action of any kind or nature, whether known or unknown, based upon, arising out of, or connected with, directly or indirectly, any term, provision, fact, event or occurrence related to or contained in the Lease.

In addition, pursuant to Section 7.3 of the Lease, Republic may elect to remove the buildings and permanent improvements from the premises within 90 days after the Termination Date.
