Project Understanding

This scope of this project shall be to provide Construction Phase Services during the construction of a 92'x70' hangar, as previously designed under Amendment No. 7.

Detailed Scope of Services

- A. Task 5CON – Construction Administration Services. Parkhill will:
 - 1. Prepare Construction Contract
 - 2. Conduct Pre-Construction Meeting
 - 3. Review and approve Contractor's Material Submittals
 - 4. Review and approve Contractor's Monthly Pay Applications
 - 5. Review Construction Materials Reports from Owner's Testing Lab
 - 6. Prepare Change Orders (if required)
 - 7. Conduct Final Inspection and Prepare Punchlist

- B. Task 6RPR-Resident Project Representative Services. Parkhill will:
 - 1. Provide RPR services as detailed in Exhibit C of Owner-Engineer Agreement, "Duties, Responsibilities, and Limitations of Authority of Resident Project Representative". RPR time reflects maximum of 20 Working Days and proposed on lump sum basis.
 - 2. RPR to be present during construction of hangar slab and apron paving operations. Resident Project Representative services not provided for hangar construction beyond completion of slabs.

- C. Task 9SSC-Construction Materials Testing and Review. Parkhill, through a qualified subconsultant, will:
 - 1. Provide required Construction Materials Testing, in accordance with the testing frequencies defined in the Project Specifications, through an independent materials testing laboratory and review all testing that is performed by the Contractor

- D. Task 12OG-OAC Grant Administration Services. Parkhill will:
 - 1. Prepare OAC Grant Application
 - 2. Prepare Monthly OAC Partial Pay Request Form (reimbursement)
 - 3. Prepare Construction Management Program per OAC requirements
 - 4. Prepare OAC Closeout Documentation
