1. CALL TO ORDER

Chairman Ken Baker called the meeting to order at 4:07 p.m.

3. DISCUSSION, CONSIDERATION AND POSSIBLE ACTION REGARDING:

- A. Donation of Former Glancy Motel & Pop Hicks Restaurant Properties for the Construction of a New OHP Troop H Headquarters in Clinton, OK.**

City Manager Johnston reported that the necessary documents to proceed with this transaction had been prepared by the DPS legal staff with review and input from City Attorney Meacham regarding an offer by CEDA to donate, with a reversionary clause, of the former Glancy Motel & Pop Hicks Restaurant properties for the construction of a new OHP Troop H Headquarters in Clinton, OK. Economic Developer Roland Mower stated that the Authority still needs to determine the value of this donation of land to include in the letter. He suggested the expenses that the City of Clinton has paid totals approx. \$650,000. The Authority members discussed the Letter of Intent with the State of Oklahoma and agreed on the estimated value of \$650,000.

Johnston also reported that he had delivered the properties' abstracts to the Department of Public Service for their review in late August, that we have a signed contract with Midwest Wrecking to commence demolition no later than October 9, 2023, and that he has had several conversations with DPS representatives which indicate their full intent to proceed with this project as discussed. Mayor Berrong wanted to ensure that a legal contract commitment was received from the State for the DPS/OHP for the proposed building of the new Troop H location prior to the demolition starting. The Trustees agreed. The draft letter offering to donate the land was reviewed as was the draft deed, and Resolution 964 - A Resolution of the Clinton City Council Authorizing Conveyance of this Real Property to the State of Oklahoma for the Oklahoma Highway Patrol Troop Headquarters.

Motion was made by Trustee Max McKinsey and seconded by Trustee Canda Dupree to approve the Donation of Former Glancy Motel & Pop Hicks Restaurant Properties for the Construction of a New OHP Troop H Headquarters in Clinton, OK with value of \$650,000.00.
