Re: Outdoor swimming facility brush-blast, paint, and repairs

Dear Mr. Johnston,

This proposal is offered to accomplish the following items of work for the City of Clinton outdoor swimming facility. Items of work include the following:

1. Brush blasting (lite sandblasting) the main pool, wading pool, and plunge pool interior surfaces to prepare surface for epoxy coating.
2. Application of "Themec" epoxy paint (12 mil to 15 mil 3 coats).
3. Repair approximately 100 square feet of spalling area in the pool floor (chip back patch with one inch cap).
4. Repair race lane tile, replace approximately 10sq ft of tile.
5. Repair and replace 10 lf +/- of 2x2 tile on overflow next to grating.
6. Grout race lanes tile.
7. Clean tile behind gutter grate and caulk above tile.
8. Establish caulk joint between deck and top of pool wall on wading pool, paint coping blue as before, include face above caulk jt.
9. Two days of wall and floor spalling and divot repair after sandblasting on main pool. We are not resurfacing the interior but we are addressing the worst areas.
10. Grating Replacement in areas (approximately 10 ft, grating) secure frame that grate rest on in two areas.

This proposal is for the sum of One Hundred Thirty-Seven Thousand, Seven Hundred Nine Dollars (**\$137,709.00**) and is valid for thirty days. The pool is to be drained and ready for us to begin work.

With sandblasting we will put used sand in totes in the pools. The city is responsible for lifting the totes out and hauling off and disposing of the sand.

Prep, install multi-coat and apply 100% quartz plaster system to pool.

\*This price will need to be re-evaluated before starting project. Tile repair would be billed additional. This project would need to be started in January or February to ensure ready to swim in May. City of Clinton would need to provide us a place to dispose of old plaster. After plaster this pool will need to remain full of water year-round. Plaster is meant to be underwater and if pool is drained and left, warranty will be voided.
