AGENDA ITEMS 3. PUBLIC HEARING REGARDING ALLEGED DILAPIDATED STRUCTURES AT 1011 AVANT OWNED BY JOHN W. OSBORNE

Code Enforcement Toby Anders presented the information regarding the property at 1011 Avant owned by John W. Osborne. The property deteriorated over the years and has not had active water service since August 2020. Mr. Osborne was sent a violation notice 6/10/24 on the condition of the structure and the unkept yard. The owner failed to secure the house or mow the yard. On August 14, 2024, the City of Clinton held an abatement hearing to address the condition of the property, the owner failed to appear at the hearing. Since the owner failed to appear at the hearing the City Manager ordered that the yard be mowed, the structure be secured and move forward towards potential condemnation and abatement of the structure. When the contractor secured the structure, I took photos of the interior of the house which showed clear signs of squatters and vandalism in the residence. The Clinton Police Department has also received numerous calls regarding unauthorized people in the house which they removed. The Notice of Hearing was sent by certified mail, posted on the structure on 11/18/24 and published in the Clinton Daily newspaper on 11/19/24. Additionally, there has not been any response to letters mailed to the J.P. Morgan Chase mortgage holder of the property.

Neither the property owner nor any representative was in attendance to report on their intentions regarding the property.
